He also complains of not being able to sleep due to his breathing problem.

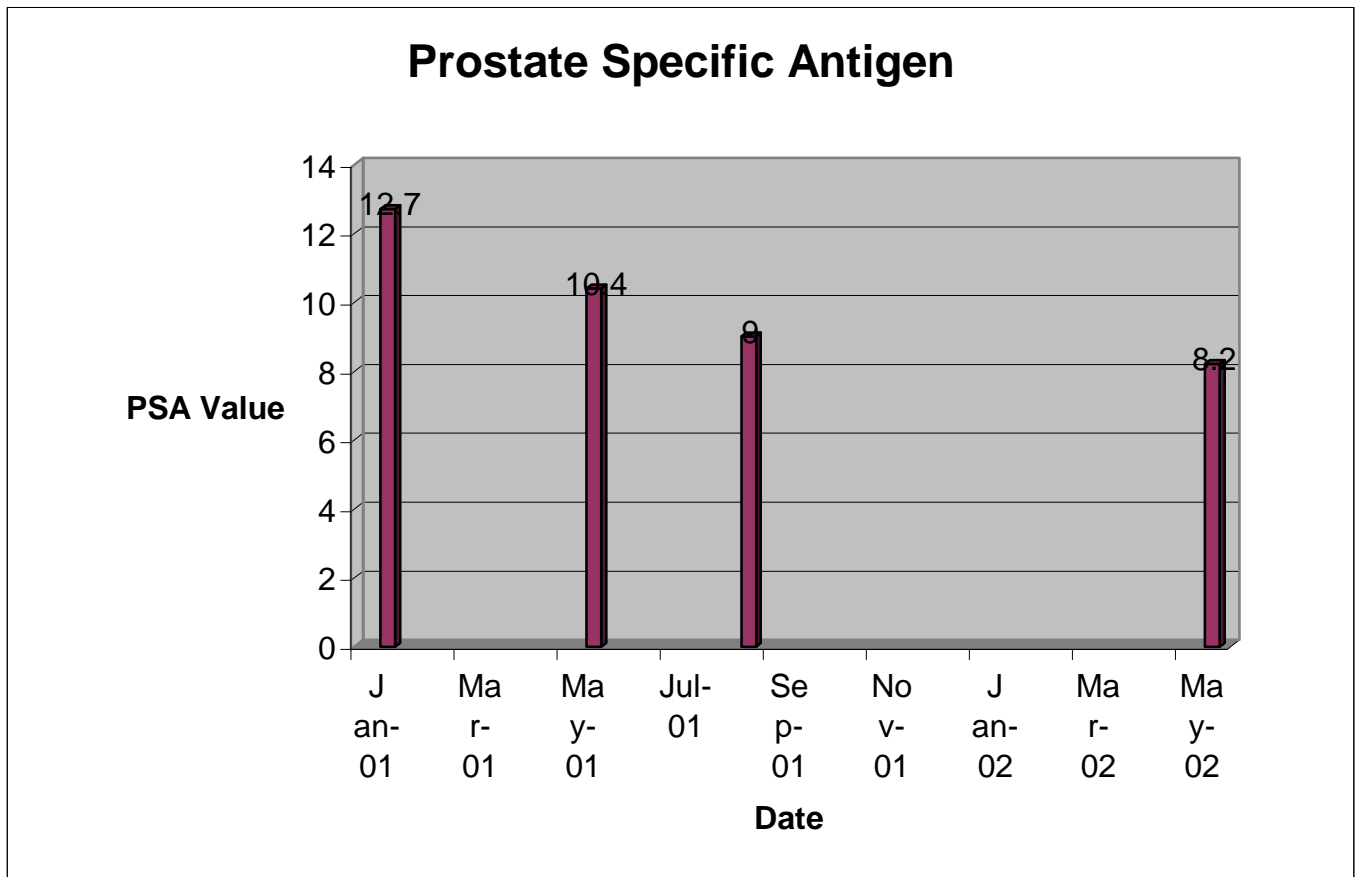

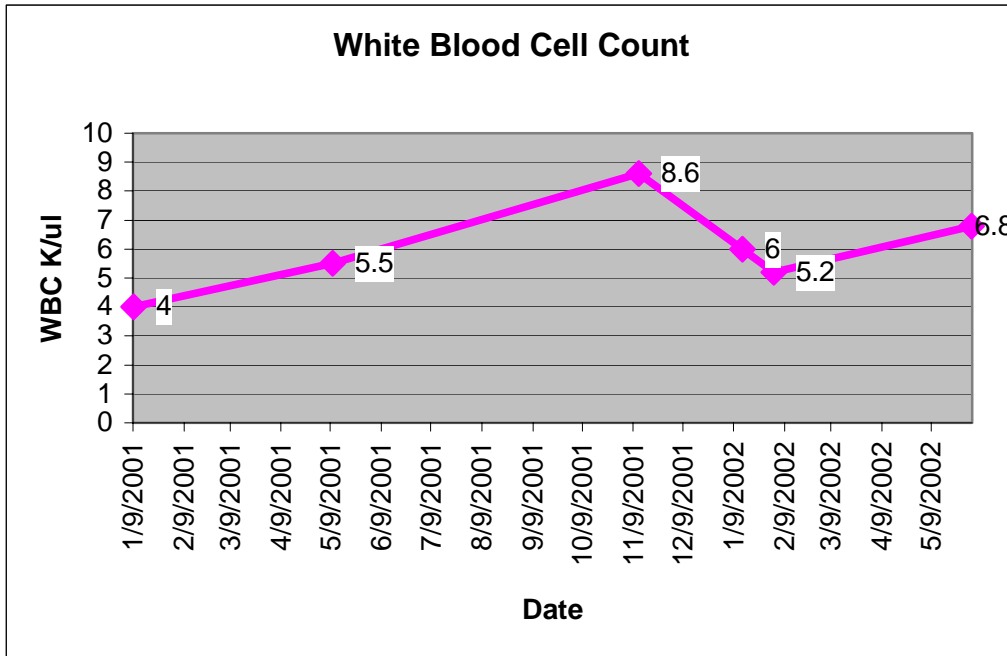

Normal PSA <4



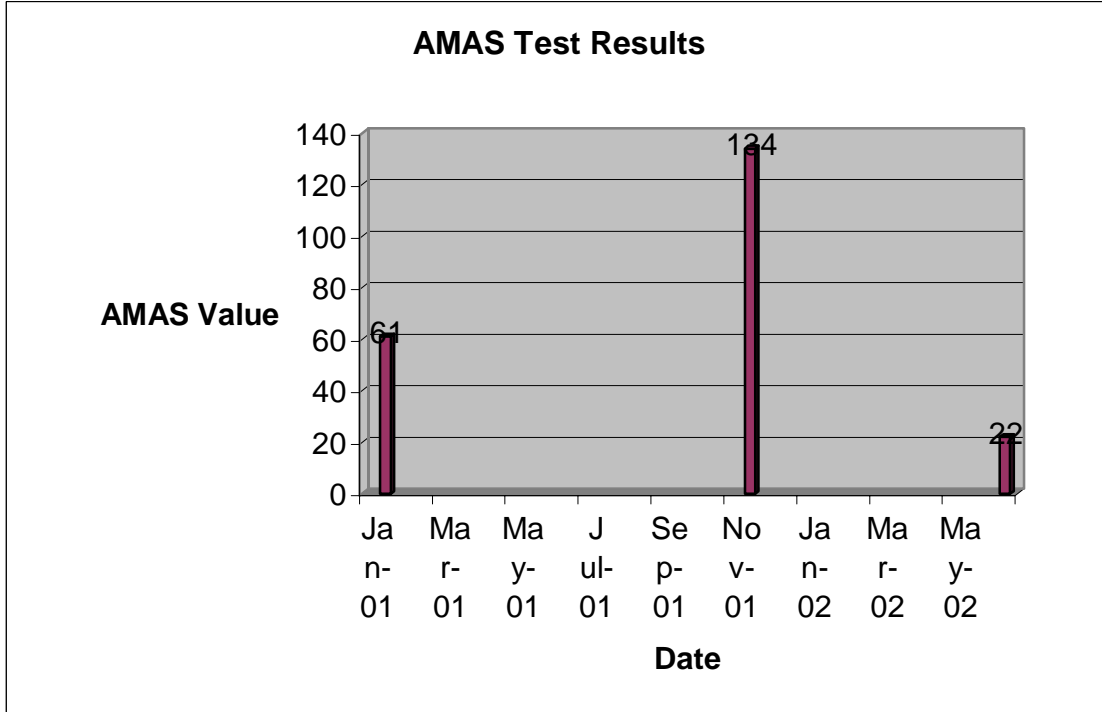
Normal Values > 4.1

This graph demonstrates documented increases in AMAS values with increasing immune response. This continues until the body reaches a level of immune response to kill cancer cells, and then these values drop as presented in this case.

02/2400 Prostate Cancer Determined by Biopsy

12/10/01 Patient presented to us with prostate cancer. Fatigue, depression and lethargy are the chief physical complaints. He is also suffering from frequent urination that keeps him waking up at night.

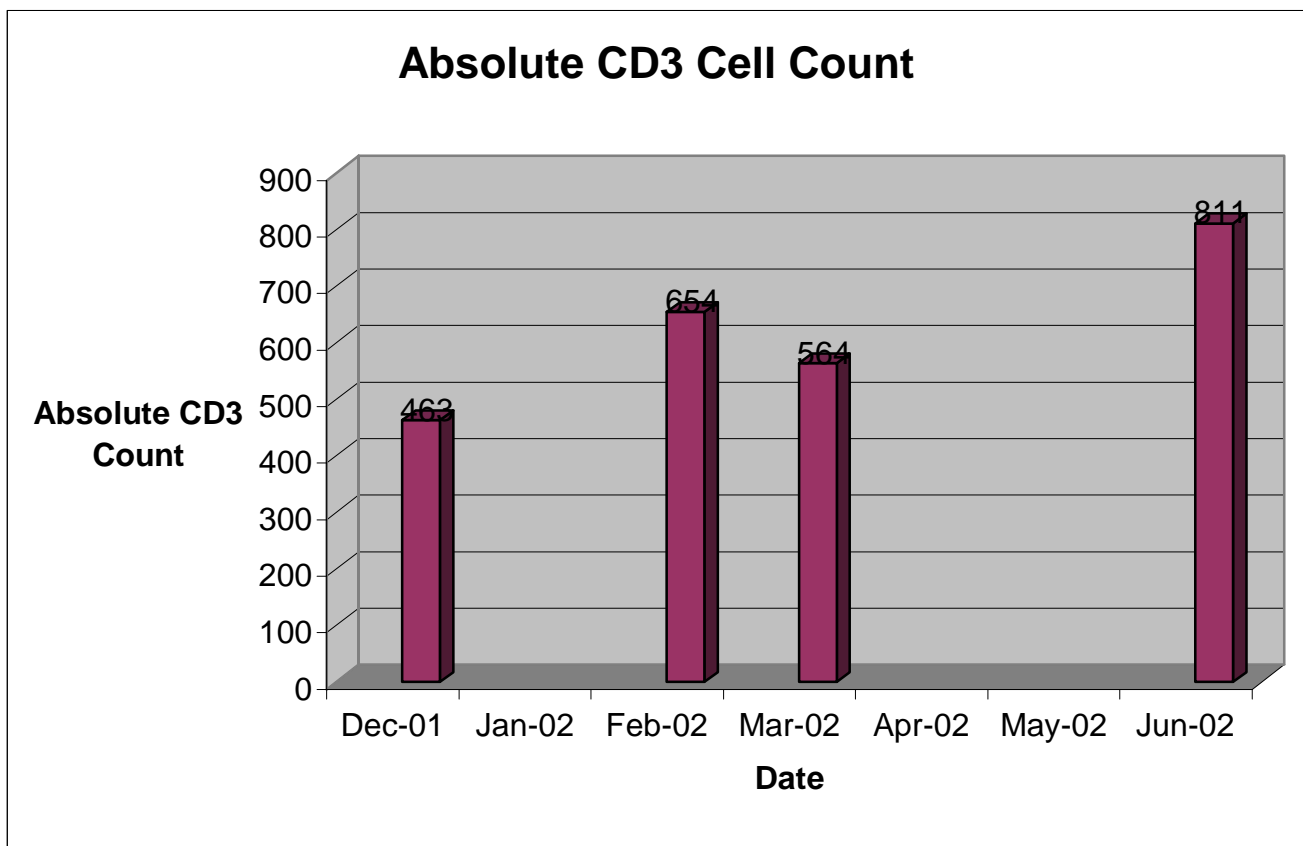
12/10/01 Started LifeOne Formula
